



## City Council votes to support second phase of East Portland Pilot Project

Heather Hoell, Executive Director of Venture Portland, attended METBA board's June meeting to announce that the Portland City Council unanimously voted to extend funding to support the East Portland Pilot Project for a second year. The demonstration project was designed to provide targeted support to guide Eastside business districts and associations in efforts to increase association membership, volunteers and revenue.

Business associations that would like to continue to receive funds for signature events and to strengthen their member and volunteer infrastructures are asked to participate in a board strategy session; complete a twelve-month work plan; agree to an annual check-up and benchmark review; and attend Quarterly Quadrant Conversations to ensure the success of their grant activities.

The METBA board voted to approve participation in the project for a second year. The board can choose to focus its work on established events while meeting priorities outlined in last year's work plan.

Grant funds will continue to support the goals of the project, though the board has discretion on where funds will be allocated. Board members expressed interest in continuing events that have engaged new constituents and promoted involvement by business and community members. These include the district mixers, First Fridays, the Glisan Street Halloween event, and a continuation of the annual Montavilla Street Fair. METBA members have an opportunity to weigh in at the general membership meeting in July.
