# PROPOSED: BUSINESS LICENSE TAX INCREASE

#### The Situation:

Mayor Wheeler proposed an increase to the Business License Tax in his 2018-19 Budget along with an offsetting increase to the Owners Compensation Deduction.

- 3. Share this information with district businesses and encourage them to send a letter\* on their business's letterhead to every member of City Council doing the same
- 4. Take it to the next level and attend a Budget Hearing at City Council on Thursday, 5/10 or Wednesday, 5/16

### \*Letter best practices:

- E-mail is quick and easy
- Can be as short as 3 sentences (see sample template)
- Be respectful
- Letters must be individually addressed/sent to each Council Member (don't send 1 email to all 5 Council Members)
- Letters must be sent before the budget is approved on May 16
